<b>Does your homeowner's insurance cover less than 80% of the home's replacement value?</b> If so, increase the coverage limit as the insurance carrier may not fully cover the cost of damage caused by an insured event. <b>Have you made substantial capital improvements to the property (such as a swimming pool, addition, or renovation)?</b> If so, consider the following: <ul style="list-style-type: none"> <li>■ Check that your insurance covers a minimum of 80% of the replacement value of the house.</li> <li>■ Additional liability protection may be needed.</li> </ul>	<input type="checkbox"/>	<input type="checkbox"/>
<b>Has the value of the property increased substantially since the last time you reviewed your homeowner's coverage?</b> If so, consider checking that your insurance covers a minimum of 80% of the replacement value of the property.	<input type="checkbox"/>	<input type="checkbox"/>
